

Terms and conditions of the Reactile subscription to the Enterprise Licence Agreement.

The Reactile software includes the source code, library and documentation, sample programs (hereinafter the 'Software')

- Is conceded in the form of an annual or monthly subscription,
- The licence for final use, and not assigned, by IMPLEX SASU
- For professional use only by a Company in accordance with the terms of this Licence.

IMPLEX SASU reserves all property rights not expressly granted to you. You install the downloaded media on which the Software is installed on your private workstation, but of which IMPLEX SASU retains ownership.

1. SUBSCRIPTION AND RENEWAL.

Subscribing online at www.reactile.net either on a monthly basis or for twelve months for a professional user entitles you to:

- Contractual responsiveness from the support team
- Technical support via @mail: support.reactile@implex.fr
- In the event of an incident or the reproduction of a bug, a corrective patch will be delivered
- A new version of the product if it is released during the contracted subscription period: with all patches and any enhancements
- An automatic renewal of the subscription
- If the subscription renewal is stopped, if the customer wishes to take up the subscription again, they will have to pay for the subscription to be taken up again at the current price.

2. ENTERPRISE USE LICENCE

The Reactile subscription from IMPLEX SASU grants you a subscription for an end-user licence which allows you to use a single copy of the Software for a professional user via his Company.

A licence key corresponds to a single copy of the Software. You must pay an annual or monthly subscription fee to use the Software. This subscription must be renewed according to the expiry dates of your contracted subscription.

A licence key entitles you to use the Software for development purposes. It grants you an unlimited number of deployments, on the express condition that these are for non-commercial purposes.

In addition to your licence keys linked to your subscriptions, you must take out a deployment licence per domain name for any deployment for commercial purposes.

Depending on the terms of your subscription to this licence, you may:

- 1.1 Make an unlimited number of copies with any modifications whatsoever, provided that such copies are for internal use only and are not for professional distribution or republication, from this computer.
- 1.2 Use and modify the Examples, provided that you do not distribute or republish the Examples, or any modified version of the Examples in the source code form.
- 1.3. Redistribute the software files with your professionally developed products.

The Software is 'in use' when you develop source code dependent on the Software and link your projects to the libraries (original or modified).

3. EXCLUSIONS.

You should not :

- 3.1. Distribute or publish any part of the Software (original or modified) unless you have received written permission from IMPLEX SASU.
- 3.2. Redistribute the Software as part of a software development library without the written permission of IMPLEX SASU.
- 3.3. Do not pass on to anyone your annual user subscription number that you have received from IMPLEX SASU.
- 3.4. You may not lend, give, rent, sub-licence or transfer the Registered Software and related documents to third parties without the written authorisation of IMPLEX SASU.
- 3.5. Do not use your standard development licence keys for commercial deployments.

4. DELIVERY Reactile subscription Enterprise

IMPLEX provides the following elements:

A package available on npm.js under the @implex/reactile identifier that can be installed on the command line, along with all the related documentation.

5. COPYRIGHT PROTECTION.

The Reactile Software and its content are the intellectual property of IMPLEX SASU and are protected by international copyright laws and associated treaty agreements.

6. LIMITED WARRANTY

The Reactile Software is licensed on an 'AS IS' basis. If for any reason you are dissatisfied with the Software, delete it from your computer system and destroy all copies of it.

In no event will IMPLEX SASU be liable to you for any damages, including lost profits, lost savings or other incidental or consequential damages arising out of your use of or inability to use the Software.

7. NO LIABILITY.

By installing and using the Software, you hereby agree to hold IMPLEX SASU harmless from any loss, direct or consequential damage or claim incurred by you resulting from reliance on the results obtained from the use of the Software.
